NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of January 28, 2015 is made by PNC Bank, National Association, in its capacity as agent for the Lenders (together with its successors and assigns in such capacity, "Agent") in favor of Hoover Group, Inc., a Delaware corporation, and Hoover Materials Handling Group, Inc. (each, a "Grantor" and collectively, the "Grantors") pursuant to that certain Revolving Credit, Term Loan and Security Agreement dated as of March 4, 2009 (and as the same may be further amended or modified from time to time, the "Credit Agreement") among Grantors, certain of their affiliates, the lenders from time to time party thereto (the "Lenders"), and Agent.

WITNESSETH:

WHEREAS, in connection with the Credit Agreement, the Grantors executed and delivered a Trademark Security Agreement, dated as of March 4, 2009, in favor of the Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors pledged and granted to the Agent for the benefit of the Agent a continuing security interest in all of their Trademark Collateral (as that term is defined in the Security Agreement), including but not limited to the trademark registrations set forth on Schedule A attached hereto (the "Released Trademarks");

WHEREAS, the Agent recorded its security interest in the Released Trademarks in the United States Patent and Trademark Office on June 15, 2009 at Reel 4008 Frame 0504 between the Grantor and the Agent;

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the Released Trademarks;

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.


NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Grantors, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement, as applicable.

SECTION 2. Release of Security Interest. The Agent does hereby release, relinquish and discharge its security interest in, and right of setoff against, all of the Grantors' right, title and interest in, to and under the Released Trademarks and all right, title and interest of the Grantors in the Released Trademarks are hereby reassigned by the Agent to their respective Grantors.

IN WITNESS WHEREOF, the Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date set forth above.
