

RELEASE OF GRANT OF A SECURITY INTEREST - TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of January 11, 2017, is made by Bank of America, N.A. (“Lender”).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of August 13, 2015 (the “Trademark Security Agreement”), recorded in the United States Patent and Trademark Office (“USPTO”) at Reel 5602, Frame 0436 on August 13, 2015, Herr Holdings, Inc., a Delaware corporation (the “Grantor”), granted to Lender a continuing security interest in all right, title and interest of Grantor in, to and under certain Trademark Collateral as set forth in the Trademark Security Agreement; and

WHEREAS, certain of the Trademarks set forth on Schedule 1 to the Trademark Security Agreement are registered to Herr Holdings – CFI, Inc. and not to the Grantor;

WHEREAS, Grantor has requested and Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Lender’s security interest in certain of the Trademark Collateral as specifically listed on Schedule A attached hereto.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Lender and Grantor hereby agree as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Lender hereby (i) releases, relinquishes and discharges any and all right, title, and interest in and to the Trademark Collateral listed on Schedule A attached hereto, without further representation or warranty and (ii) authorizes the recordation of this Release with the USPTO.
3. Limited Release. Except as expressly set forth herein, nothing in this Release or any other correspondence or any oral communications between Lender and Borrower should be construed be a release or a discharge of any of the Lender’s rights, title, and interest in and to the Trademark Collateral.
