INTELLECTUAL PROPERTY RELEASE AND REASSIGNMENT

THIS INTELLECTUAL PROPERTY RELEASE AND REASSIGNMENT is made as of January 26, 2017, by Golub Capital Markets LLC (f/k/a GCI Capital Markets LLC), a Delaware limited liability company ("Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, C. B. Fleet Company, Incorporated, a Virginia corporation and C.B. Fleet Investment Corporation, a Delaware corporation (collectively, the "Grantor") and Secured Party were parties to that certain Intellectual Property Security Agreement dated as of December 15, 2015 (the "Security Agreement") pursuant to which the Grantor granted a security interest to Secured Party in certain Trademarks, Patents, Copyrights and IP Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the registrations and applications set forth on Schedules I, II and III annexed hereto;

- 2. Secured Party hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in and to the Trademarks, Patents, Copyrights and IP Collateral.
