NOW, THEREFORE, Tropo and Cisco agree as follows and confirm that:



Tropo has assigned and transferred, and Cisco has received and accepted, all of Tropo's rights, title and interest throughout the world in and to the Tropo Marks and all the rights, claims and privileges pertaining to the Tropo Marks, including without limitation: the registrations and applications pertaining thereto (except for Tropo's Intent-to-Use US applications for which Amendments to Allege Use or Statements of Use have not yet been filed with the US Patent and Trademark Office), together with all of the goodwill of the business associated with and symbolized by the Tropo Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Tropo in all matters related thereto.


Tropo hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign countries to implement this Assignment.
