NOTICE OF SUCCESSION OF AGENCY

WHEREAS, the Original Credit Agreement was amended and restated, and the Original Guarantee and Collateral Agreement was amended, as of December 1, 2016 (as amended and restated, collectively, the "Current Agreements"), and in connection with the transactions under the Current Agreements, the Prior Agent, the Successor Agent, the Borrower and certain other parties have entered into that certain Agency Transfer Agreement, dated as of December 1, 2016, whereby the Prior Agent resigned as Administrative Agent and Collateral Agent and was succeeded to and replaced by the Successor Agent as successor Administrative Agent and Collateral Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:


1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Agency Transfer Agreement.


2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Agency Transfer Agreement, the Prior Agent has ceased to be Administrative Agent and Collateral Agent and is succeeded to and replaced by the Successor Agent as Administrative Agent and Collateral Agent. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Agent under the Original Guarantee and Collateral Agreement, which security interest is now succeeded by and transferred to the Successor Agent.


