RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This Release of Notice of Grant of Security Interest in Trademarks (this “Release”) is made as of February 15, 2017, by BANK OF AMERICA, N.A., in its capacity as Administrative Agent and Collateral Agent for the Lenders under (and as defined in) the Security Agreement referred to below (the “Collateral Agent”) for the benefit of HERBALIFE INTERNATIONAL, INC., a Nevada corporation, with principal offices at 800 West Olympic Boulevard, Suite 406, Los Angeles, California 90015 (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

W I T N E S S E T H:

WHEREAS, the Grantor and the Collateral Agent are parties to that certain (i) Amended and Restated Security Agreement, dated as of May 4, 2015 (as amended, restated or otherwise modified through the date hereof, the “Security Agreement”); and (ii) Notice of Grant of Security Interest in Trademarks, dated as of May 4, 2015 (as amended, restated or otherwise modified through the date hereof, the “Trademark Security Agreement”), pursuant to which the Grantor has granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantor in, to and under the Trademark Collateral, including the trademarks set forth on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on May 7, 2015 at Reel 5512 and Frame 0297; and

WHEREAS, Grantor has requested that the Collateral Agent release, and the Collateral Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Trademark Security Agreement to the Trademark Collateral and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in the Trademark Collateral to the Grantor.


