RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of February 24, 2017 ("Effective Date") by **BANK OF AMERICA, N.A.**, in its capacity as agent for its own benefit and the benefit of other Credit Parties ("Grantee"), in favor of **LIMITED STORES, LLC**, a Delaware limited liability company ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain **GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** dated May 27, 2015, by and between Grantor and Grantee (the "Grant"), Grantor granted to Grantee a continuing security interest in all of Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all renewals of any of the foregoing, (iii) all General Intangibles (as defined in the Security Agreement referred to below) connected with the use of, or related to, any and all Marks (including, without limitation, all goodwill of the Grantor and its business, products and services appurtenant to, associated with, or symbolized by, any and all Marks and the use thereof), (iv) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect to any of the foregoing, including, without limitation, payments under all Licenses (as defined in the IP Security Agreement referred to below) entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, (v) the right to sue for past, present and future infringements and dilutions of any of the foregoing, (vi) all of the Grantor's rights corresponding to any of the foregoing throughout the world, and (vii) all products, proceeds, substitutions, and accessions of or to any of the foregoing;

WHEREAS, Grantor and Grantee entered into the Grant pursuant to the terms and conditions of that certain **SECURITY AGREEMENT** by and between Grantor and Grantee dated August 24, 2007 (as amended, restated, supplemented or otherwise modified and in effect from time to time, the "Security Agreement") by, among others, the Grantor and the Grantee;

WHEREAS, the Grant was recorded with the United States Patent and Trademark Office ("PTO") on May 28, 2015, at Reel/Frame 5524/0806;

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Grant and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.



Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
