INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, dated as of February 28, 2017 (this "*Assignment Agreement*"), is by and among Ibis Tek, LLC, a Pennsylvania limited liability company ("*Ibis Tek*"), Ibis Tek Apparel, LLC, a Pennsylvania limited liability company ("*Ibis Tek Apparel*"), Ibis Tek Properties, LLC, a Pennsylvania limited liability company ("*Ibis Tek Properties*"), Verbuck, LLC, a Pennsylvania limited liability company ("*Verbuck*" and together with Ibis Tek, Ibis Tek Apparel and Ibis Tek Properties, collectively, the "*Assignors*" and each an "*Assignor*"), and Ibis Tek, Inc., a Delaware corporation (the "*Assignee*").

All capitalized terms used and not otherwise defined in this Assignment Agreement shall have the respective meanings given to such terms in the Purchase Agreement (as defined below).

WITNESSETH:

WHEREAS, Assignors and Assignee are parties to an Asset Purchase Agreement, dated December 30, 2016 (the "*Purchase Agreement*"), providing for the sale of all of Assignors' right, title and interest in and to the Acquired Assets; and

WHEREAS, in accordance with the terms of the Purchase Agreement, Assignors and Assignee have agreed to provide for the assignment from Assignors to Assignee of all of Assignors' right, title and interest in and to the Intellectual Property Assets of the Business.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment. Assignors hereby sell, convey, transfer, assign and deliver to Assignee, its successors and assigns, all of the right, title and interest of Assignors throughout the world in and to the Intellectual Property (as that term is defined in the Purchase Agreement) including the Intellectual Property Assets set forth on Schedule 1 hereto (collectively, the "*Assigned Intellectual Property*"), including, but not limited to, all inventions and invention rights covered thereby, all issues of letters patent and reissues, continuations, continuations-in-part, divisions and reexaminations of the letters patent already granted and which may be granted in all countries, all of the common law rights and registrations in all countries relating to the transferred marks and the goodwill symbolized thereby in all countries, and all rights to sue for and remedies and damages against past, present and future infringements thereof, to be held and enjoyed by Assignee and its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignors if this assignment had not been made.

2. Further Assurances. Each of the parties hereto shall, and shall cause each of its affiliates to, from time to time, execute and deliver to the other party such additional instruments, assignments, documents, conveyances or assurances, including, without limitation, such patent assignments, trademark assignments, assignments of unpatented inventions and assignments of unregistered trademarks, in form and substance reasonably satisfactory to Assignors and Assignee, as shall be reasonably requested by Assignee, and take such other action as shall be

reasonably necessary to confirm and consummate more effectively the transactions contemplated hereby. All costs associated with filing and recording such assignments and other documents shall be borne by Assignee.

3. Binding Effect. This Assignment Agreement shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.

4. No Modification of the Purchase Agreement. This Assignment Agreement shall be subject to and governed by the terms and conditions of the Purchase Agreement. No provision of this Assignment Agreement shall in any way modify the express provisions (including, without limitation, the warranties, representations, covenants, agreements, conditions, or any of the obligations and indemnifications of the parties hereto) set forth in the Purchase Agreement, this Assignment Agreement being intended solely to effect the transfer of certain property sold and purchased by Assignee pursuant to and in accordance with the Purchase Agreement.

5. No Waiver or Modification. Neither this Assignment Agreement nor any term hereof may be changed, waived, discharged or terminated other than by an instrument in writing signed by Assignors and Assignee.

6. No Third Party Beneficiaries. This Assignment Agreement is for the sole and exclusive benefit of Assignee and its successors and permitted assigns and nothing herein is intended or shall be construed to convey upon any person other than Assignee and its successors and permitted assigns any rights, remedies or claims under, or by any reason of, this Assignment Agreement or any term, covenant or condition hereof.


7. Counterparts. This Assignment Agreement may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment Agreement and all of which, when taken together, will be deemed to constitute one and the same agreement. A signature delivered by facsimile or other electronic transmission will be considered an original signature.

8. Governing Law. This Assignment Agreement shall be governed and construed in accordance with the laws of the State of Delaware, without giving effect to the principles of conflicts of laws thereof.
