**SECOND:** The original Certificate of Formation of the limited liability company was filed on September 14, 2016.

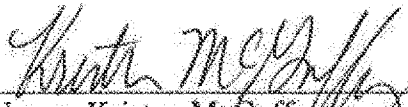
**THIRD:** The original Certificate of Formation is hereby amended by deleting Section **FIRST** in its entirety and by substituting in lieu thereof the following:
