DECLARATION OF KEVIN HERRIG


I, **Kevin Herrig**, hereby declare as follows:

corrective assignment recorded at Reel 5673, Frame 0617 was not proper because these Datalytics entities did not possess any legal rights in U.S. Registration Nos. 3046879 and 4352382 at the time these documents were made and recorded.



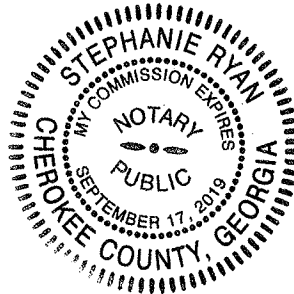
