## RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARK

This Release of Security Interest in Specified Trademark, dated as of March 3, 2017 (the "Effective Date"), is made by **Bank of America, N.A.**, a national banking association (the "Secured Party") in favor of **Headwaters Technology Innovation Group, Inc.**, a Utah corporation with an address at 10701 South River Front Parkway, Ste 300, South Jordan, Utah 84095 ("HTIG").

Reference is made to that certain Trademark Security Agreement, dated as of October 27, 2009 (the "Security Agreement"), between the Secured Party and Headwaters Incorporated (assignor of the Released Mark, as defined below, to HTIG), Tapco International Corporation, Atlantic Shutter Systems, Inc., Headwaters Resources, Inc., Dutch Quality Stone, Inc., Eldorado Stone LLC, and Eldorado Stone Operations, LLC, which Security Agreement was recorded with the United States Patent & Trademark Office's Assignment Department at Reel/Frame 4088/0431.

The Secured Party hereby:

- 1) acknowledges and confirms that, pursuant to the Loan and Security Agreement dated October 27, 2009, that required the execution and delivery of the Security Agreement, the Secured Party is hereby releasing its security interest in and to the trademark HCAT and U.S. Trademark Registration No. 3513091 relating thereto, together with the goodwill symbolized by that mark (the "Released Mark"), effective as of the Effective Date;
- 2) releases and reconveys to HTIG, without warranty or recourse, any and all of the Secured Party's right, title, claim and interest in and to the Released Mark; and
- 3) authorizes and requests the Commissioner for Trademarks and any other applicable government officer to record this release of the Secured Party's security interest in the Released Mark.

The Security Agreement shall otherwise continue to be in full force and effect, and the Secured Party is not hereby releasing any other Trademark Collateral (as defined in the Security Agreement).
