## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made by Saag's Products, LLC, a Delaware limited liability company (the "Assignor"), in favor of Jonmor Investments, Inc., a Delaware corporation (the "Assignee"), as of January 3, 2017.

WHEREAS, the Assignor is the sole owner of all of the right, title and interest in and to the trademark registrations identified in Schedule 1 attached hereto (the "Trademarks");

WHEREAS, on the date hereof, Project Utah Acquisition, LLC, a Delaware limited liability company ("Parent"), acquired the sole membership interest in Clougherty Packing, LLC, a Delaware limited liability company, of which the Assignor is a wholly owned subsidiary, pursuant to that certain Membership Interest Purchase Agreement (the "Purchase Agreement"), dated as of November 21, 2016, by and among Smithfield Foods, Inc., a Virginia corporation, and Hormel Foods Corporation, a Delaware corporation; and

WHEREAS, pursuant to that certain Trademark Purchase Agreement, dated as of the date hereof, by and between Parent and the Assignee, Parent has agreed to cause the Assignor to assign all right, title and interest in and to the Trademarks, together with the goodwill of the businesses associated with the Trademarks, to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby sells, assigns and transfers to the Assignee its entire right, title and interest in and to the Trademarks, together with the goodwill of the business associated with the Trademarks.

The Assignor agrees to take further actions and to do further things that the Assignee may reasonably request, including executing additional documents, in order to vest or perfect in the Assignee all right, title, and interest in and to the Trademarks.

This Assignment shall be effective for all purposes as of immediately after the Effective Time (as defined in the Purchase Agreement).


