RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of April 3, 2017 and granted by Bank of America, N.A., in its capacity as administrative agent (in such capacity, the “Agent”) pursuant to (i) the Security Agreement dated as of May 26, 2011 among Infogroup Inc. (the “Borrower”), the grantors party thereto (including the Grantors (as defined below)) and the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), (ii) the Trademark Security Agreement dated as of May 26, 2011, among the Grantors party thereto, and the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “2011 Trademark Security Agreement”), (iii) the Trademark Security Agreement dated as of March 30, 2012, between GoTime Corporation, a Delaware corporation, as Grantor and the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “2012 Trademark Security Agreement”), and (iv) the Trademark Security Agreement dated as of April 11, 2013, among the Grantors party thereto, and the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “2013 Trademark Security Agreement” and, together with the 2011 Trademark Security Agreement and the 2012 Trademark Security Agreement, the “Trademark Security Agreements”), in each case, in favor of each of the Grantors set forth on Schedule 1 attached hereto (collectively, the “Grantors” and each a “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings set forth in the Security Agreement.

WHEREAS, pursuant to the terms and conditions of each Trademark Security Agreement, each of the Grantors granted to the Agent a continuing security interest in all of its right, title and interest in and to the following (all of the following items or types of property being herein collectively referred to as the “Trademark Collateral”), whether now owned or existing or hereafter acquired or arising:

- (i) each Trademark constituting Material Intellectual Property owned by such Grantor (including, without limitation, each Trademark registration and application therefor, with all renewals thereof, referred to in Schedule 1 hereto, and all of the goodwill of the business connected with the use of or symbolized by, each Trademark); *provided* that no security interest was granted in any intent-to-use Trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would have impaired the validity or enforceability of such intent-to-use Trademark applications under applicable law;
- (ii) all rights in the foregoing provided by international treaties or conventions and all other rights corresponding thereto throughout the world; and
- (iii) any and all Proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and Supporting Obligations relating to, any and all of the foregoing, including, without limitation, all Proceeds of and revenues from any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect

to any of the foregoing, with the right to sue for and collect, or otherwise recover, all proceeds and damages relating thereto;

WHEREAS the 2011 Trademark Security Agreement has been recorded with the Assignment Division of the U.S. Patent and Trademark Office on July 12, 2011 at Reel 4580 and Frame 0275;

WHEREAS the 2012 Trademark Security Agreement has been recorded with the Assignment Division of the U.S. Patent and Trademark Office on April 2, 2012 at Reel 4749 and Frame 0876;

WHEREAS the 2013 Trademark Security Agreement has been recorded with the Assignment Division of the U.S. Patent and Trademark Office on April 11, 2013 at Reel 5005 and Frame 0187; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels and releases to the Grantors any and all liens and security interests it has in, to or against the Trademark Collateral.


