**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”), dated as of March 22, 2017, is made by Cortland Capital Market Services LLC, as Collateral Agent for the Secured Parties (the “**Collateral Agent**”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement and/or the Pledge and Security Agreement (as hereinafter defined)) to the parties set forth on Annex I hereto (the “**Grantors**”).

**WHEREAS**, in connection with the Second Lien Credit Agreement dated as of June 30, 2016 (together with all exhibits and schedules thereto and as the same may be amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among High Ridge Brands Co. (as successor in merger to CDR HRB Merger Sub, Inc.), CDR HRB Buyer, Inc., the Subsidiary Borrowers from time to time party thereto, the Lenders party thereto, and the Collateral Agent, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

**WHEREAS**, the Grantors agreed, pursuant to a Second Lien Pledge and Security Agreement dated as of June 30, 2016 in favor of the Collateral Agent (as amended, restated, supplemented or otherwise modified from time to time, the “**Pledge and Security Agreement**”), to grant a lien and security interest on their Collateral as security for the Obligations of the Borrower;

**WHEREAS**, in connection with the Credit Agreement and the Pledge and Security Agreement and pursuant to the (i) that certain Notice and Confirmation of Grant of Security in Trademarks, dated as of June 30, 2016, by High Ridge Brands Co., Golden Sun, Inc. and Continental Fragrances, Ltd. in favor of the Collateral Agent (the “**High Ridge, Golden Sun and Continental Fragrance Trademark Security Agreement**”), (ii) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of December 29, 2016, by Dr. Fresh, LLC in favor of the Collateral Agent (the “**Dr. Fresh Trademark Security Agreement**”) and (iii) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of December 29, 2016, by Children Oral Care, LLC in favor of the Collateral Agent (the “**Children Oral Care Trademark Security Agreement**”; and together with the High Ridge, Golden Sun and Continental Fragrance Trademark Security Agreement and the Dr. Fresh Trademark Security Agreement, the “**Trademark Security Agreements**”), each Grantor granted a security interest in all of its Trademarks and Trademark applications, including, without limitation, those referred to on Annex II hereto; all rights to sue at law or in equity for any past, present and/or future infringement or impairment of any of the foregoing, including the right to receive all proceeds and damages therefrom, and all Proceeds with respect to any of the foregoing, including claims, license fees, royalties and any other fees or payments (collectively, the “**Trademark Collateral**”); and

**WHEREAS**, the Trademark Security Agreements were recorded in the United States Patent and Trademark Office (the “**USPTO**”) as follows: the High Ridge, Golden Sun and



Continental Fragrance Trademark Security Agreement was recorded on July 1, 2016, on Frame 5826, Reel 0830; the Dr. Fresh Trademark Security Agreement was recorded on January 12, 2017 on Reel 5964, Frame 0808; and the Children Oral Care Trademark Security Agreement was recorded on January 12, 2017 on Reel 5964, Frame 0103.


**NOW THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby terminates, releases and discharges, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral, whether granted pursuant to the Pledge and Security Agreement, any Trademark Security Agreement or any other agreement or document delivered in connection with the Credit Agreement, and any and all right, title and interest (if any) that the Collateral Agent may have in the Trademark Collateral shall hereby cease and become void.

The Collateral Agent agrees, at the Grantors' expense, to cooperate with Grantors and to provide Grantors with any information or additional authorization reasonably requested by any Grantor to effect the release of the Collateral Agent's security interest in the Trademark Collateral, including by duly executing, acknowledging, procuring and delivering any further releases and documents (including without limitation Uniform Commercial Code termination statements) and doing such other acts as may be reasonably requested by any Grantor to effect the release of the security interest contemplated hereby.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.






