**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), effective as of April 7, 2017, is made by Wilmington Trust, National Association, as collateral agent (in such capacity, the "Collateral Agent"), in favor of EGL Eagle Global Logistics, L.P. and Eagle Partners, L.P. (collectively, the "Grantors").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of May 2, 2013 (the "Security Agreement"), by the Grantors to Law Debenture Trust Company of New York, recorded in the United States Patent and Trademark Office at Reel 5022, Frame 507-514, the Grantors assigned and granted to the Law Debenture Trust Company of New York a security interest in the Grantors' right, title and interest in and to all the Trademark Collateral, including, without limitation, those Trademarks listed on Exhibit A hereto;

WHEREAS, pursuant to (i) that certain Instrument of Resignation, Appointment, Acceptance and Assignment, dated as of February 6, 2017, and (ii) that certain Assignment and Assumption of Trademark Security Agreement, dated as of February 6, 2017, Law Debenture Trust Company of New York resigned, and the Collateral Agent succeeded, its position as collateral agent under, among other things, the Security Agreement; and

WHEREAS, the Collateral Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

1. Release. The Collateral Agent hereby relinquishes, releases and discharges its security interest in the Trademark Collateral and all right, title and interest of the Grantors in the Trademark Collateral are hereby reassigned by the Collateral Agent to the Grantors.

2. Further Assurances. The Collateral Agent hereby authorizes the Grantors or the Grantors' authorized representative, to record this Release with the United States Patent and Trademark Office. The Collateral Agent further agrees to execute and deliver to the Grantors any and all further documents and instruments, and do any and all further acts which the Grantors (or their agents or designees) reasonably request (at the Grantors' sole cost and expense) in order to confirm this Release and the Grantors' right, title and interest in, to and under the Released Assets.

3. Governing Law. This Release shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement.
