
FOR VALUE RECEIVED, the undersigned, WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company as agent (“Agent”), does hereby re-grant, re-assign, re-transfer and re-convey absolutely, and terminate and release any lien on and security interest in and to the Trademark Collateral (as defined below), granted and pledged to it by LEWIS COMPUTER SERVICES, LLC, a Delaware limited liability company (“Company”) (formerly known as LEWIS COMPUTER SERVICES, INC.), pursuant to that certain Trademark Security Agreement, dated as of June 4, 2010 (the “Security Agreement”), by and between Agent and Company, and re-assigns the Trademark Collateral to Company. As used herein, the term “Trademark Collateral” means (i) the trademarks and trademark applications listed on Schedule I hereto, (ii) all renewals thereof, (iii) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (iv) the right to sue for past, present and future infringements thereof, (v) all rights corresponding thereto throughout the world, (vi) all goodwill of the Grantor’s business connected with and symbolized by such trademarks and (vii) the rights granted to Agent with respect to such trademarks and trademark applications pursuant to the Security Agreement as recorded on behalf of Agent by the United States Patent and Trademark Office on June 7, 2010, at Reel/Frame 004219/0931 in the United States Patent and Trademark Office.
