

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of April 25, 2017, from Deutsche Bank AG New York Branch, as Revolving Collateral Agent (in such capacity, the "Collateral Agent") for the Secured Parties, to each of the Grantors listed on Schedule I hereto (each, a "Grantor" and collectively, the "Grantors") in connection with each of the Trademark Security Agreements listed on Schedule I hereto (collectively, the "Trademark Security Agreements", in each case, as amended, restructured, renewed, novated, supplemented, restated, replaced or otherwise modified from time to time). Capitalized terms used herein without definition have the meanings set forth in the ABL Pledge and Security Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to (i) that certain ABL Pledge and Security Agreement dated as of October 21, 2013 (as amended, restructured, renewed, novated, supplemented, restated, replaced or otherwise modified from time to time, the "ABL Pledge and Security Agreement"), among REV Group, Inc. (formerly known as Allied Specialty Vehicles, Inc.), a Delaware corporation (the "Borrower"), the other Grantors from time to time party thereto and the Collateral Agent and (ii) the Trademark Security Agreements, the Grantors assigned and pledged to the Collateral Agent, its successors and permitted assigns, for the ratable benefit of the Secured Parties, and granted to the Collateral Agent, its successors and permitted assigns, for the ratable benefit of the Secured Parties, a continuing security interest in the Trademarks (as defined in the Trademark Security Agreements), including, for the avoidance of doubt, the trademark registrations and trademark applications identified on Schedule II, all Proceeds and products of the Trademarks, the goodwill of the businesses with which the Trademarks are associated, and all causes of action for infringement of any of the Trademarks or unfair competition regarding the same (collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreements were recorded with the Trademark Division of the United States Patent and Trademark Office on the dates and at the Reel and Frame numbers listed on <u>Schedule I</u>; and

WHEREAS, the Collateral Agent is, pursuant to that certain payoff letter dated as of the date hereof among Deutsche Bank AG New York Branch in favor of the Borrower and each of the guarantors party to the ABL Pledge and Security Agreement and this Termination and Release, terminating, releasing and discharging the entirety of its continuing security interest in the Trademark Collateral in accordance with Section 10 of the ABL Pledge and Security Agreement.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks

pursuant to the Trademark Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:

- 1. <u>Release of Security Interest</u>. The Collateral Agent hereby terminates, releases and discharges its continuing security interest in all of the Grantors' right, title or interest in, to and under all of the Trademark Collateral, and any right, title or interest of the Collateral Agent or any other Secured Party therein shall hereby cease and become void.
- 2. <u>Further Assurances</u>. The Collateral Agent shall, at the expense of the Grantors, execute and deliver to the Grantors all further releases and other documents (including, without limitation, Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of the security interest in respect of the Trademark Collateral, in each case as reasonably requested by the Grantors

Nothing herein shall be construed to act as a release of, or prejudice the rights of the Collateral Agent or the Secured Parties to, the security interest created under any Security Document, other than in respect of the assets being released hereunder.
