## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of May 2, 2017, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns, the "Agent"), in favor of **CITY TOWING INC.**, a Nevada corporation, **E & R TOWING AND GARAGE INC.**, an Illinois corporation and **URS SOUTHWEST, INC.**, a Delaware corporation (jointly and severally, "Grantors" and each individually the "Grantor"). All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

**WHEREAS**, the Grantors executed and delivered a Trademark Security Agreement dated as of August 21, 2014 (the "***Trademark Security Agreement***") granting the Agent a security interest in and lien on certain Trademark Collateral (as defined in the Trademark Security Agreement);

**WHEREAS**, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on August 25, 2014, at Reel 5350, Frame 0903; and


**WHEREAS**, the Grantors have requested that the Agent provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Trademark Collateral as herein provided.
