WHEREAS Assignor has certain rights in and to a trademark asset identified in Schedule A hereto ("the Trademark Asset"); and


WHEREAS Assignee is desirous of acquiring all right, title, and interest in and to the Trademark Asset;

IN WITNESS WHEREOF, the parties have caused this Assignment to be executed by their duly authorized officers as of the date first written above.


