**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 12, 2017 ("Release"), is made by Bank of America, N.A., as Collateral Agent ("Collateral Agent") in favor of Outerwall Inc. (n/k/a Coinstar, LLC), a Delaware Corporation ("Grantor").

**WHEREAS**, pursuant to that certain Collateral Agreement dated as of September 27, 2016 (as amended, restated, supplemented, or otherwise modified from time to time, the "Collateral Agreement") by and among the Grantor, each subsidiary of the Grantor and the Collateral Agent, Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to all Trademarks, Trademark Licenses, and Proceeds of the foregoing (collectively, "Trademark Collateral"); and

**WHEREAS**, pursuant to the Collateral Agreement, Grantor executed and delivered to Collateral Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest (Second Lien) in Trademarks recorded at the United States Patent and Trademark Office ("USPTO") on September 28, 2016 at Reel/Frame 5885/0656 ("Notice").

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement or Notice.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, hereby:

- (a) without any representation, warranty, or recourse, terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to, and the right to set off against, Grantor's right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement or Notice;
- (b) without any representation, warranty, or recourse, terminates and cancels the Notice; and
- (c) authorizes the recordation of this Release with the USPTO at Grantor's expense, in order to memorialize the release of the security interest of the Collateral Agent in the Trademark Collateral.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**SECTION 4. Further Assurances.** The Collateral Agent further agrees to execute and deliver to Grantor any and all further documents and instruments, and do any and all further acts which Grantor (or its agents or designees) reasonably requests (at Grantor's sole costs and expense) in order to confirm this Release and Grantor's right, title and interest in and to the Trademark Collateral.

**IN WITNESS WHEREOF**, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.


