## CERTIFICATE OF AMENDMENT

### OF THE AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF FYNANZ, INC.

Fynanz, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), certifies that:

1. The name of the Corporation is Fynanz, Inc.
