## ASSIGNMENT OF TRADEMARKS

ASSIGNOR further authorizes the United States Patent and Trademark Office to record said assignment so as to show ownership of the Marks in the name of International Merchandising Company, LLC; and

ASSIGNOR further agrees to execute such further documents as may reasonably be required to record ASSIGNEE as the owner of the Marks and applications and/or registrations herein assigned.
