**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “Release”), dated as of May 31, 2017, is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent for the Secured Parties (the “Administrative Agent”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement dated as of June 12, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Upsher-Smith Laboratories, Inc., a Minnesota corporation (the “Company”), the Foreign Subsidiary Borrowers, the Lenders party thereto, the Issuing Bank and Administrative Agent, the Lenders have agreed to make loans and extend other financial accommodations to or for the benefit of the Company;

**WHEREAS**, USL Pharma, Inc., a Minnesota corporation (the “USL Pharma”) has guaranteed the repayment of the Secured Obligations pursuant to an Amended and Restated Guaranty dated as of September 1, 2015 (as may be amended, restated, supplemented or otherwise modified from time to time);

**WHEREAS**, the Company and USL Pharma have entered into an Amended and Restated Pledge and Security Agreement dated as of September 1, 2015 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

**WHEREAS**, in connection with the Credit Agreement, Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the “IP Security Agreements”), the Company granted security interests in certain intellectual property owned by Company, including those listed on Annex I attached hereto (the “IP Collateral”); and

**WHEREAS**, the IP Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto.


**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the IP Collateral, whether granted pursuant to the Security Agreement, the IP Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the IP Collateral to Company, as applicable.

The Administrative Agent agrees, at Company's expense, to cooperate with Company and to provide Company with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
