TRADEMARK SECURITY AGREEMENT—INDENTURE

This TRADEMARK SECURITY AGREEMENT dated as of May 31, 2017 (this “Agreement”), is made by and among PetSmart, Inc.; Pacific Coast Distributing, Inc.; Pet360, Inc.; PETMD, Inc.; PetSmart Home Office, Inc.; All Paws, Inc.; and Chewy, Inc. (each, a “Grantor” and, collectively, the “Grantors”) and The Bank of New York Mellon Trust Company, N.A., a national association located at 400 South Hope St., Suite 400, Los Angeles, CA 90071, as Collateral Agent (in such capacity, the “Collateral Agent”).

Reference is made to (a) the Indenture dated as of May 31, 2017 (as amended, supplemented or otherwise modified from time to time, the “Indenture”, the notes issued thereunder the “Notes”), among PetSmart, Inc., a Delaware corporation (the “Issuer”) and The Bank of New York Mellon Trust Company, N.A., as Notes Trustee, and the various other parties thereto and (b) the Collateral Agreement dated as of May 31, 2017 (as amended, supplemented or otherwise modified from time to time, the “Collateral Agreement”) among the Issuer, the various grantors party thereto The Bank of New York Mellon Trust Company, N.A. The Holders have agreed to purchase and hold the Notes subject to the terms and conditions set forth in the Indenture. Each Grantor is an Affiliate of the Issuer and is willing to execute and deliver this Agreement as consideration for the purchase of the Notes. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Collateral Agreement or the Indenture, as applicable. The rules of construction specified in Section 1.01(b) of the Collateral Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance and full and punctual payment when due, whether at maturity, by acceleration or otherwise, of all Obligations of the Issuer under the Notes and the Indenture, each Grantor hereby grants to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under any Trademarks now owned or at any time hereafter acquired by such Grantor, including those listed on Schedule I (the “Trademark Collateral”).


SECTION 3. Collateral Agreement. The Security Interest granted to the Collateral Agent herein is granted in furtherance, and not in limitation, of the security interests granted to the Collateral Agent pursuant to the Collateral Agreement. The Grantors hereby acknowledge and affirm that the rights (including any indemnity rights), privileges, powers, protections, immunities, benefits and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement and the First Lien Intercreditor Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.

SECTION 4. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Agreement.






