## ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS is effective November 1, 2014, and is executed and delivered this 8<sup>th</sup> day of December, 2014 by and among PBI-GORDON CORPORATION, a Missouri corporation with its office at 1217 West 12th Street, Kansas City, Missouri, 64101 ("PBI"); PET-AG, INC., a Delaware Corporation and subsidiary of PBI, with its office at 255 Keyes Avenue, Hampshire, IL 60140 (hereinafter "PetAg" or "Buyer"); and PEGASUS LABORATORIES, INC., a Missouri corporation and subsidiary of PBI, with its office at 8803 Ely Road, Pensacola, FL 32514 ("Pegasus") (each a "Party" and collectively the "Parties").

WHEREAS, PBI is the owner of or has rights in certain trademarks particularly described in Schedule A-1 (the "PBI Trademarks"), including all common law rights related thereto, and made a part hereof; and

WHEREAS, Pegasus is the owner of or has rights in certain trademarks particularly described in Schedule A-2 (the "Pegasus Trademarks"), including all common law rights related thereto, and made a part hereof; and

WHEREAS, each of PBI and Pegasus wish to convey all of its right, title and interest in and to the Trademarks to PetAg.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. PBI hereby sells, grants, assigns, conveys and transfers unto PetAg, all of PBI's right, title and interest in and to the Trademarks, the Registrations, and all common law rights related thereto for the marks shown on Schedule A-1, together with the goodwill of the business connected with the use of, and symbolized by, such Trademarks.

2. Pegasus hereby sells, grants, assigns, conveys and transfers unto PetAg, all of Pegasus' right, title and interest in and to the Trademarks, the Registrations, and all common law rights related thereto for the marks shown on Schedule A-2, together with the goodwill of the business connected with the use of, and symbolized by, such Trademarks.

3. PBI and Pegasus agree that they shall execute all further documents reasonably necessary to perfect PetAg's title to the Trademarks as shown on Schedule A-1 and A-2.
