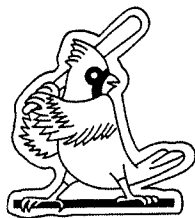

**DECLARATION OF ETHAN G. ORLINSKY**

ETHAN G. ORLINSKY, pursuant to 28 U.S.C. 1746, declares:

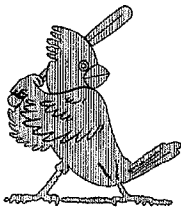
1. I am Corporate Secretary of Major League Baseball Properties, Inc. ("MLBP"), the agent for all of the MAJOR LEAGUE BASEBALL clubs, including St. Louis Cardinals, LLC (the "Registrant"), which is the owner of the ST. LOUIS CARDINALS MAJOR LEAGUE BASEBALL club (the "Club") and all of its U.S. trademarks and registrations, including, without limitation, the above-captioned registration (the "Registration") for the Cardinal and Bat



Design mark shown here: (the "Registrant's Mark"). I make this declaration to correct the erroneous recordal of security agreements (the "Security Agreements") filed by the now dissolved firm Jenkins & Gilchrist, P.C. on behalf of the National Bank of Canada on June 21, 1997 at the Assignment Recordation Branch of the United States Patent and Trademark

Office (“USPTO”) in connection with the above-captioned registration (the “Registration”). I make this declaration based upon personal knowledge and upon consultation of business records kept in the ordinary course of business.

2. In addition to the Registration, Registrant is the owner of numerous U.S. federal registrations for trademarks used in connection with the Club’s goods and services, including Registration Nos. 843,040 for the Registrant’s Mark lined for the color red shown here



(the “Red Cardinal and Bat Design Mark”)

3. On June 27, 1997, the now dissolved firm of Jenkins & Gilchrist, P.C. mistakenly recorded the Security Agreements at Reels/Frames 1618/0908, 1618/024 and 1618/0974 that erroneously listed the Registration. The clear mistake is revealed by the facts that: (i) the Club’s Red Cardinal and Bat Design Mark is not included as one would expect, (ii) the Assignors of the security interest is not the Club, which owned the Registration, but rather Old America Wholesale, Inc., Old America Store, Inc. and Old America Stores, Inc., respectively, and (iii) the other registrations included in the list are also OLD AMERICA marks and not marks of the Club. A copy of the TSDR record for Registration No. 2,073,120 for OLD AMERICA is attached hereto as Exhibit A. This shows that the same three Reel/Frame records that list the Registration are shown as Assignments 2, 3 and 4 in the record of the OLD AMERICA mark.

4. Further, it appears that the firm that filed the Security Agreements, erroneously included the Registration in the Security Agreements instead of U.S. Registration Number 1,562,781 for

OLD AMERICA STORES, the TSDR record of which is attached here as Exhibit B. It appears that a typographical error in the registration number was made as Registration No. 1,562,781 for OLD AMERICA STORES differed by only one digit from the Registration.

4. At no time did Registrant enter into the Security Agreements with the National Bank of Canada that were recorded in the USPTO.

5. Accordingly, Registrant requests that this correction to the Assignment records be recorded in order to reflect the true chain of title of the Registration.
