RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release") is dated as of May 5, 2017. The Agent hereby notifies, acknowledges to and agrees with the Obligor that the security interest granted by the Obligor in the Intellectual Property Collateral (as defined in the Trademark Security Agreement), including, without limitation, in the United States Trademarks (as defined in the Trademark Security Agreement) listed on Schedule A attached hereto, is terminated and released, and that the Agent hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed in the Intellectual Property Collateral pursuant to the Trademark Security Agreement.


The Agent hereby agrees to execute and deliver, or cause to be duly executed and delivered, to the Obligor such further instruments and do and cause to be done such further acts (in each case, at the Obligor's expense and by documentation provided to and approved by the Agent) as may be required in the reasonable opinion of the Obligor to effect and evidence this Release, including, without limitation, the execution and delivery of any filings, statements, amendments, recordations or other instruments required to maintain the applications or registrations of the Intellectual Property Collateral and record the chain of title accordingly with the United States Patent and Trademark Office.


This Release shall be governed by and construed in accordance with the laws of the State of New York.
