**TERMINATION AND RELEASE OF
TRADEMARK SECURITY INTEREST**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST dated as of June 30, 2017 (this "Release"), is made by Wells Fargo Bank, National Association, as collateral agent (in such capacity, the "Collateral Agent") acting for the benefit of the Secured Parties (as defined in the Security Agreement).

A. Reference is made to (i) the Indenture, dated as of April 23, 2014 (the "Indenture"), among Florida East Coast Holdings Corp., a Florida corporation ("Holdings"), Florida East Coast Industries, LLC, a Delaware limited liability company ("FECI" and together with Holdings, the "Issuers"), the guarantors party thereto and Wells Fargo Bank, National Association, as Trustee and collateral agent (the "Trustee"), as supplemented by the First Supplemental Indenture, dated as of April 28, 2015, among Raven Transport Holdings, Inc., a Florida corporation, the Issuers, the guarantors party thereto and the Trustee, (ii) the Security Agreement, dated as of April 23, 2014 (the "Security Agreement"), among Holdings, each of the Subsidiary Grantors (as defined in the Security Agreement and, together with Holdings, the "Grantors") and the Collateral Agent, as supplemented by Supplement No. 1 to the Security Agreement, dated as of April 28, 2015, among Raven Transport Holding, Inc., a Florida corporation and the Collateral Agent and (iii) the Trademark Security Agreement, dated as of April 23, 2014 (the "Trademark Security Agreement"), among Florida East Coast Railway Corp., a Delaware corporation and the Collateral Agent. Capitalized terms used but not defined herein have the meanings assigned to such terms in the Trademark Security Agreement.

B. Pursuant to the Indenture, the Security Agreement and the Trademark Security Agreement, each Grantor pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all its right, title and interest in, to and under all of its U.S. Trademarks and all proceeds thereof, including those set forth on Schedule I hereto (the "Released Trademarks"), which security interest was recorded with the United States Patent & Trademark Office as of April 23, 2014, at Reel/Frame 5266/0814.

C. As a consequence of the redemption of all Notes and other amount owing under the Indenture and the release of security interests under the Security Documents (as defined in the Indenture) and the termination of the Indenture, the Security Agreement and the Trademark Security Agreement, the Grantors have requested the Collateral Agent release all right, title and interest of the Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the U.S. Trademarks granted under the Indenture, the Security Agreement and the Trademark Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges all right, title and interest (including, without limitation, security interests) of the Collateral Agent in and to the U.S. Trademarks, including the Released Trademarks.

The Collateral Agent agrees to perform all further acts and execute and deliver, at the Issuers' expense, all further documents and/or instruments that may be necessary to carry out the provisions of this Release. Any execution and delivery of documents or instruments, including this Release, shall be without recourse to, or representation or warranty by, the Collateral Agent.

Delivery of an executed page to this Release by facsimile transmission or other customary means of electronic transmission (e.g., "pdf") shall be effective as delivery of a manually signed Release.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
