#### RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of July 26, 2017, by UBS AG, STAMFORD BRANCH, a Swiss bank with offices located at 677 Washington Boulevard, Stamford, CT 06901, in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Collateral Agent"), in favor of COMMUNICATIONS & POWER INDUSTRIES LLC, a Delaware limited liability company, CPI MALIBU DIVISION, a California corporation, CPI LOCUS MICROWAVE, INC., a Delaware corporation and ASC SIGNAL CORPORATION, a Delaware corporation (individually, a "Pledgor," and, collectively, the "Pledgors"). Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement (as defined below).

**WHEREAS**, the Pledgors are party to: (i) that certain Second Lien Security Agreement, dated as of March 17, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of the Collateral Agent and (ii) that certain Trademark Security Agreement between the Pledgors and the Collateral Agent dated as of March 17, 2017 (the "Trademark Security Agreement");

**WHEREAS**, pursuant to the Trademark Security Agreement, as collateral security for the payment and performance in full of the Secured Obligations, each Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all of the following (collectively, the "Trademark Collateral"):

- (a) Trademarks of such Pledgor listed on <u>Schedule I</u> attached hereto;
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing (other than Excluded Property):

**WHEREAS**, the Trademark Security Agreement was recorded with the U.S. Patent & Trademark Office on March 21, 2017, at Reel 6014 and Frame 0672; and

**WHEREAS**, the Pledgors have requested that the Collateral Agent release, and the Collateral Agent has agreed to release, its lien on and security interest in and to the Trademark Collateral and to reconvey any and all rights in the Trademark Collateral to the Pledgors.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges and releases fully with respect to each Pledgor any and all liens and security interests it has in and against such Pledgor's Trademark Collateral.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademark Collateral of any Pledgor, it hereby irrevocably re-assigns and re-

transfers all such rights, title and interest it may have in such Trademark Collateral (including, without limitation, the Trademark Collateral on Schedule I) to such Pledgor and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.

The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer or agency record this Release.

The Collateral Agent shall take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors, and at Pledgors' sole cost and expense (unless otherwise provided under the Security Agreement), to more fully and effectively effectuate the purposes of this Release.

This Release and the transactions contemplated hereby, and all disputes between the parties under or relating to this Release or the facts or circumstances leading to its execution, whether in contract, tort or otherwise, shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be executed and delivered by its duly authorized representative as of the date first set above.
