This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (the "Release"), dated as of July 24, 2017, is made by BNP PARIBAS, as Administrative Agent for the Lenders (the "Secured Party"), pursuant to the Credit Agreement, dated as of December 30, 2015, (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Credit Agreement") and the Security Agreement, dated as of December 30, 2015, (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Security Agreement").

WITNESSETH

WHEREAS, DEXTER MARINE PRODUCTS LLC, a Delaware limited liability company (the "Grantor") is a party to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Secured Party that certain (i) Grant of Patent Security Interest, dated as of December 30, 2015 and recorded with the United States Patent and Trademark Office ("USPTO") on December 30, 2015 at Reel/Frame No. 37387/0945 (the "Patent Security Agreement") and (ii) Grant of Trademark Security Interest, dated as of December 30, 2015 and recorded with the USPTO on December 30, 2015 at Reel/Frame No. 5699/0843 (the "Trademark Security Agreement") (the "Trademark Security Agreement") and together with the Patent Security Agreement, the "Intellectual Property Security Agreements"), pursuant to which the Grantor granted to the Secured Party a security interest in all of its right, title and interest in and to the Patent Collateral (as defined in the Patent Security Agreement) and Trademark Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Intellectual Property Security Agreements have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Secured Party release its security interest in all of its right, title and interest in and to the Patent Collateral and Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in and to the Patent Collateral and Trademark Collateral, including the patents and trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Secured Party may have obtained in, to and under the Patent Collateral and Trademark Collateral under the Intellectual Property Security Agreements and the Security Agreement. The Secured Party hereby authorizes the Grantor or its authorized representative to record this Release with the USPTO and/or otherwise record or file this Release in the applicable governmental office or agency.
