**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

WHEREAS, Nuverra Environmental Solutions, Inc. (the "Company") entered into a Trademark Security Agreement, dated as of April 15, 2016 (as heretofore amended, modified or supplemented, the "Security Agreement") among the Company, the other grantors party thereto, and Wilmington Savings Fund Society, FSB, as collateral trustee (the "Collateral Trustee") pursuant to which the Company granted a security interest (the "Security Interest") in all of the Company's right, title and interest in and to the Trademarks (as defined in the Security Agreement), including without limitation the trademark registrations and trademark applications set forth on the attached Schedule A (the "Trademarks"), all to the extent set forth in the Security Agreement;

WHEREAS, a Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office on April 15, 2016 at Reel 5771 and Frame 0709;


WHEREAS, the Company has requested and the Collateral Trustee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the relinquishment and discharge of its security interest in and to the Trademarks; and

WHEREAS, all of the obligations secured by the Security Interest have been fully paid and/or deemed satisfied and the Collateral Trustee desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Trustee, without warranty or recourse of any kind; hereby releases its Security Interest held in the Trademarks, including without limitation the trademark registrations and trademark applications set forth on the attached Schedule A annexed hereto, and hereby, (i) terminates all its rights, powers, privileges and remedies under the Security Agreement with respect to the Trademarks, (ii) re-conveys, re-transfers and sets over to the Company any right, title or interest that the Collateral Trustee may have acquired in the Trademarks, together with all the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Security Agreement related to the Trademarks.
