**TRADE MARK ASSIGNMENT AGREEMENT**

**BETWEEN**

(a) **United Cashmere Brands Vedjegyhasznosito KFT**, a company registered under Hungarian law, whose registered office is at H-1036 Budapest, Becsi ut 52, Hungary (herein the "**Assignor**");

and

(b) **The Ballantyne Cashmere UK Limited**, a company registered under English law, Company No. SC263388, whose registered office is at Caerlee Mills, Innerleithen, Peeblesshire EH 44 6HP (herein the "**Assignee**").

**RECITALS**

- (A) The Assignor is the proprietor of the registered trade marks and the applicant for the trade mark applications, including renewals, short particulars of which are set out in the schedule to this Agreement.
- (B) The Assignor wishes to assign the Trade Marks and Applications to the Assignee together with the goodwill associated with them.

**THE PARTIES AGREE AS FOLLOWS**

**1. INTERPRETATION**

In this Assignment Agreement:

- 1.1 The Recitals and Schedules form an integral part to the Agreement.
- 1.2 The following expressions shall have the following meaning:

**"Agreement"** means this trade mark assignment agreement;

**"Trade Marks"** means the "**BRAEMAR**" (word and/or device) registered trade marks and applications listed in Schedule 1 to this Agreement and/or common law rights, in respect of all the goods or services indicated in Schedule 1;

**2. ASSIGNMENT**

2.1 In consideration of Euro 45,210.5 (forty five thousand two hundred and ten/5) paid by the Assignee to the Assignor, receipt of which is hereby acknowledged, the Assignor hereby assigns to the Assignee:

- (a) all property, right, title and interest in the Trade Marks listed in Schedule 1, together with the goodwill associated with the Trade Marks; and including
- (b) the right to sue for damages and all other remedies in respect of any infringement of the Trade Marks which may have occurred prior to the date of this Assignment; and
- (c) all rights of priority (or to claim priority) attaching to the Trade Marks.

**3. FURTHER ASSURANCE**

3.1 The Assignor shall promptly at the request of the Assignee:

- (a) do all acts and execute and swear all documents that are reasonably necessary to vest absolute and legal and beneficial ownership of the Trade Marks in the Assignee (or to the Assignee's nominee) or to perfect the Assignee's (or the Assignee's nominee) title thereto;
- (b) give to the Assignee such reasonable assistance as the Assignee may request in evidencing the Assignee's (or the Assignee's nominee) title to the Trade Marks;
- (c) give to the Assignee such reasonable assistance in demonstrating the validity of and opposing any action or counterclaim to revoke the Trade Marks and any trade marks registered pursuant to the applications including providing evidence of the use of the relevant marks.

**4. MISCELLANEOUS**

4.1 If in any country the execution of a confirmatory assignment or other such document in respect of the Trade Marks would be ineffective or invalid by reason of the transfer effected by this Agreement, then this Agreement shall be deemed to be an agreement to assign, and not an assignment of the Trade Marks in that country.

**5. GOVERNING LAW**

5.1 This Agreement and the jurisdiction clause contained in it shall be governed by, construed and take effect in accordance with English law.

5.2 It is agreed that the Courts of England and Wales shall have non-exclusive jurisdiction to settle any claim, dispute or matter which may arise out of or in connection with this Agreement.


