**FIRST AMENDMENT TO
MEMORANDUM AND NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This FIRST AMENDMENT TO MEMORANDUM AND NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "First Amendment") amends and shall be considered a part of that certain Memorandum and Notice of Security Interest in Intellectual Property (the "**Memorandum**"), dated as of May 9, 2017, by Sonic.net, LLC, a Delaware limited liability company (by statutory conversion from Sonic.net, LLC, a California limited liability, by statutory conversion from Sonic.net, Inc., a California corporation) ("**Debtor**").

WHEREAS reference is made to that certain Security Agreement, dated March 10, 2014, by and among Debtor, Sonic Telecom, LLC, a California limited liability company, Bank of America, N.A., its successors and assigns ("**BANA**") and to Bank of America Corporation and its subsidiaries and affiliates (BANA and all such secured parties, collectively, the "**Bank**").

WHEREAS reference is also made to the Memorandum and Notice of Security Interest in Intellectual Property, dated May 9, 2017, executed by Debtor, which was recorded with the United States Patent and Trademark Office on May 25, 2017, and was designated Reel/Frame 6069/0141 as a reference number.

WHEREAS Debtor and Bank are concurrently herewith entering into an Amended and Restated Security Agreement whereby the parties will be reaffirming the security interest in all general intangibles, which include the trademark registrations listed in Exhibit A, attached hereto.

NOW, THEREFORE, it is hereby agreed that Debtor and the Bank reaffirm the security interest in the trademark registrations listed in Exhibit A.

Except as expressly amended or modified pursuant to this Amendment, the Memorandum shall remain otherwise unchanged and in full force and effect.
