**ASSIGNMENT OF TRADEMARK
SECURITY AGREEMENT**

This **ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT** (this “*Assignment*”), dated as of September 11, 2017, is by General Electric Company (successor in interest by merger to General Electric Capital Corporation) (individually, “*GE*”), acting in its capacity as the current and resigning administrative agent (in such capacity, the “*Retiring Agent*”) and **ARES CAPITAL CORPORATION** (individually, “*Ares*”), acting in its capacity as the successor administrative agent (in such capacity, the “*Successor Agent*”).

RECITALS:

WHEREAS, Drayer Physical Therapy Institute, LLC, as “Grantor”, and Retiring Agent, as “Administrative Agent” are parties to that certain Trademark Security Agreement, dated as of July 2, 2012 and recorded with the United States Patent and Trademark Office on July 2, 2012 at Reel 4813, Frame 0139 (as the same has been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “*Agreement*”) conveying certain intellectual property set forth on Exhibit A hereto; and

WHEREAS, pursuant to that certain Agency Resignation and Appointment Agreement dated as of September 1, 2017 by and among GE, as the Retiring Agent, and Ares, as Successor Agent, Retiring Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacity as administrative agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retiring Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreements.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.


