TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of September 19, 2017 by **PNC BANK, NATIONAL ASSOCIATION** (the "*Bank*"), in favor of **BELL PLANTATION, INC.**, a Delaware corporation (the "*Grantor*").

WHEREAS, the Grantor executed and delivered that certain Trademark Security Agreement, dated as of October 31, 2014 (the "*Agreement*"), granting the Bank a security interest in and lien on certain trademarks described and defined therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on November 21, 2014, at Reel 5405, Frame 0709 and a subsequent filing for a security interest in additional trademarks, dated July 31, 2015 and recorded at the USPTO on August 10, 2015 at Reel 5596, Frame 0697;

WHEREAS, the Grantor has requested that the Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the trademarks as fully described on the attached Schedule I (collectively, the "*Trademarks*") as herein provided; and


WHEREAS, the Grantor has requested that the Bank provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:



