**RELEASE OF GRANT OF SECURITY INTEREST  
IN CERTAIN INTELLECTUAL PROPERTY**

This Release of Grant of Security Interest in Certain Intellectual Property (this “Release”) is entered into this 22nd day of September, 2017 by and between Wells Fargo Capital Finance, LLC (f/k/a Congress Financial Corporation (Central)), as administrative agent (in such capacity, together with its successors and permitted assigns, the “Agent”) for the Lenders (as defined in the Credit Agreement referred to below and each of the entities listed on the signature pages hereof (each a “Grantor” and, collectively, the “Grantors”).

**W I T N E S S E T H :**

WHEREAS, the Agent for the benefit of the Lenders holds a security interest in Grantors’ intellectual property set forth in Schedule 1 hereto (the “Intellectual Property”);

WHEREAS, pursuant to the Amended and Restated Loan and Security Agreement, dated as of December 20, 2012 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among JIII LLC (the “Borrower”), the Lenders and the Agent, the Lenders severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, each Grantor agreed, pursuant to a Guarantee dated as of August 16, 2001 in favor of the Agent (as the same may be reaffirmed, amended, restated, supplemented or otherwise modified from time to time, the “Guaranty Agreement”) to guarantee the Obligations (as defined in the Credit Agreement);

WHEREAS, all of Grantors are party to a General Security Agreement and Trademark Security Agreement (each dated as of August 16, 2001 and as the same may be reaffirmed, amended, restated, supplemented or otherwise modified from time to time the “Security Agreements”) pursuant to which the Grantors are required to execute and deliver a trademark security agreement; and

WHEREAS, the trademark security agreement (the “Trademark Security Agreement”) was recorded at the United States Patent and Trademark Office, on December 28, 2012, at Reel 4927, Frame 0966; and

WHEREAS, the Borrower and Grantors have requested that the Agent on behalf of the Lenders release all of the Lenders’ security interests in the Intellectual Property, and the Agent on behalf of the Lenders has agreed to do so.

NOW THEREFORE, in consideration of the foregoing, the parties to this Release intending to be legally bound, agree as follows.

1. The Agent on behalf of the Lenders hereby releases in its entirety any and all security interests it has against the Intellectual Property, and the Lenders hereby agrees, at the expense of the Borrower and Grantors, to take any actions and to execute any further documents necessary or reasonably requested by the Borrower and Grantors to effectuate or evidence such

release, including, but not limited to, the execution and delivery of those documents necessary under Article 9 of the Uniform Commercial Code or other applicable law.

2. The parties hereto authorize and request the Commissioner of Patents and Trademarks of the United States to record this Release against the Intellectual Property.

3. This Release shall be governed by and construed in accordance with the laws of the State of Illinois without regard to the conflict of law principles thereof.


4. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.

5. All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the parties hereto.

6. This Release may be executed in any number of separate counterparts, each of which, when so executed, shall be deemed an original, and all of said counterparts taken together shall be deemed to constitute but one and the same instrument.


