TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of October 5, 2017 (“Effective Date”), by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, (successor to General Electric Capital Corporation, a Delaware corporation) in its capacity as agent for the Lender Group, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, “Grantee”), in favor of **UNISYS CORPORATION**, a Delaware corporation, as borrower (“Grantor”).

WHEREAS, reference is made to that certain Credit Agreement, dated as of June 23, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among the lenders identified on the signature pages thereof, Grantee, Grantor, Unisys Holding Corporation, Unisys NPL, Inc., and Unisys AP Investment Company I;

WHEREAS, pursuant to the Credit Agreement, that certain Trademark Security Agreement, dated as of June 23, 2011, by and among Grantor and Grantee, which was recorded with the United States Patent and Trademark Office (the “USPTO”) on June 24, 2011 at Reel 4569, Frame 0333 (the “2011 Trademark Security Agreement”), in which the Grantor granted to Grantee a security interest in all of the Grantor’s right, title and interest in and to the “Trademark Collateral” (as such term is defined in the 2011 Trademark Security Agreement, the “2011 Trademark Collateral”).

WHEREAS, pursuant to the Credit Agreement, that certain Trademark Security Agreement, dated as of September 6, 2016, by and among Grantor and Grantee, which was recorded with the USPTO on October 4, 2016 at Reel 5891, Frame 0421 (the “2016 Trademark Security Agreement”), in which the Grantor granted to Grantee a security interest in all of the Grantor’s right, title and interest in and to the “Trademark Collateral” (as such term is defined in the 2016 Trademark Security Agreement, the “2016 Trademark Collateral”);

WHEREAS, pursuant to the Credit Agreement, that certain Trademark Security Agreement, dated as of January 3, 2017, by and among Grantor and Grantee, which was recorded with the USPTO on January 9, 2017 at Reel 5962, Frame 0096 (the “January 2017 Trademark Security Agreement”), in which the Grantor granted to Grantee a security interest in all of the Grantor’s right, title and interest in and to the “Trademark Collateral” (as such term is defined in the January 2017 Trademark Security Agreement, the “January 2017 Trademark Collateral”);

WHEREAS, pursuant to the Credit Agreement, that certain Trademark Security Agreement, dated as of April 27, 2017, by and among Grantor and Grantee, which was recorded with the USPTO on May 11, 2017 at Reel 6055, Frame 0160 (the “April 2017 Trademark Security Agreement”), in which the Grantor granted to Grantee a security interest in all of the Grantor’s right, title and interest in and to the “Trademark Collateral” (as such term is defined in the April 2017 Trademark Security Agreement, the “April 2017 Trademark Collateral”);

WHEREAS, pursuant to the Credit Agreement, that certain Trademark Security Agreement, dated as of May 4, 2017, by and among Grantor and Grantee, which was recorded with the USPTO on August 3, 2017 at Reel 6121, Frame 0981 (the “May 2017 Trademark Security Agreement”) (May 2017 Trademark Security Agreement, together with the 2011 Trademark Security Agreement, 2016 Trademark Security Agreement, January 2017 Trademark Security Agreement and April 2017 Trademark Security Agreement, the “Trademark Security Agreements”), in which the Grantor granted to Grantee a security interest in all of the Grantor’s right, title and interest in and to the “Trademark Collateral” (as such term is defined in the May 2017 Trademark Security Agreement, the “May 2017 Trademark

Collateral”) (the May 2017 Trademark Collateral, together with the 2011 Trademark Collateral, 2016 Trademark Collateral, January 2017 Trademark Collateral and April 2017 Trademark Collateral, the “Collateral”); and

WHEREAS, Grantee now desires to release its security interest in the Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest and pledge in the Collateral granted pursuant to the Trademark Security Agreements, and reassigns to Grantor all right, title, and interest of Grantee in the Collateral pursuant to the Trademark Security Agreements.


2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantor’s expense, as may be reasonably necessary to effect the release of the security interest in the Collateral contemplated hereby. Grantee hereby authorizes the Grantor and any of its respective designees to file this Release with the USPTO.

3. This Release shall be subject to the provisions regarding governing law, waiver of jury trial, and submission to jurisdiction set forth in Sections 8.11, 8.13, and 8.14 of the Guaranty and Security Agreement (as defined in the 2016 Trademark Security Agreement), and such provisions are incorporated herein by this reference, *mutatis mutandis*.
