## CONFIRMATORY ASSIGNMENT OF SECURITY INTEREST

This Confirmatory Assignment of Security Interest ("Confirmatory Assignment") is effective as of October 12, 2017, by and from Paraco Gas Corporation, a New York corporation having a place of business at 800 Westchester Avenue, Suite 604 South, Rye Brook, New York 10573 ("Assignor") to and in favor of People's United Bank, National Association, a national banking association organized under the laws of the United States, having a place of business at 350 Bedford Street, Stamford, Connecticut 06901 ("PUB"); Bank of America, N.A., a national banking association with a place of business at 360 Hamilton Avenue, White Plains, New York 10601 ("BOA"); and Signature Bank, a banking institution with a place of business at 565 Fifth Avenue – 8<sup>th</sup> Floor, New York, New York 10017 ("SB"; and, together with PUB and BOA, "Assignees").

WHEREAS, Assignor is the owner of the marks ("Marks") that are the subject of application or registration with the United States Patent and Trademark Office ("USPTO Applications and Registrations"), as listed at Schedule A hereto, and the good will associated therewith;

WHEREAS, Assignor and Assignees have entered into a Loan and Security Agreement with an effective date of October 12, 2017 ("Loan and Security Agreement"), pursuant to which Assignor has granted to Assignees a security interest in and to the USPTO Applications and Registrations, the Marks, and the good will associated therewith;

WHEREAS, this Confirmatory Assignment is granted in conjunction with the security interest granted by Assignor to Assignees under the Loan and Security Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and in the Loan and Security Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

(a) This Confirmatory Assignment is made to secure the satisfactory performance and payment of all obligations of Assignor, pursuant to the Loan and Security Agreement. Upon payment in full of all obligations, Assignees shall, upon such satisfaction, execute, acknowledge, and deliver to Assignor a written instrument releasing the security interest in and to the USPTO Applications and Registrations, the Marks, and the good will associated therewith, acquired under this Confirmatory Assignment.

(b) Assignor hereby assigns and grants to Assignees a security interest in (1) all of Assignor's right, title and interest in and to the USPTO Applications and Registrations, and the Marks, as set forth on Schedule A hereto, and the good will associated therewith, now owned or from time to time after the date hereof owned or acquired by Assignor, together with (2) all proceeds and products of the USPTO Applications and Registrations, the Marks, and the good will associated therewith, and (3) all causes of action arising prior to or after the date hereof for infringement of any of

the USPTO Applications and Registrations, the Marks, and the good will associated therewith, or unfair competition regarding the same.

(c) Assignees' rights and remedies with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Loan and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provision of this Confirmatory Assignment is deemed to conflict with the Loan and Security Agreement, the provisions of the Loan and Security Agreement shall govern.

NOW, THEREFORE, be it known and confirmed that under the Loan and Security Agreement, and this Confirmatory Assignment, effective as of October 12, 2017, Assignor granted to Assignees a security interest in and to the USPTO Applications and Registrations, the Marks, as set forth on Schedule A, and the good will associated therewith.




