## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made and effective as of October 24, 2017 and granted by PNC Bank, National Association (the "Bank") in favor of Sales Performance Holding Company, a Delaware Corporation ("SPH") and Sales Performance International, LLC, a North Carolina limited liability company ("SPI") (SPH, together with SPI, the "Grantors" and each a "Grantor").

**WHEREAS**, in order to secure certain indebtedness, the Grantors entered into a Security Agreement (the "Security Agreement") and Rider to Security Agreement (the "Rider"), both dated as of September 15, 2014, among Grantors and Bank and also into certain other financing documents and security agreements execute by and among the Grantors and Bank (all such documents, including the Rider, being collectively referred to as "Loan Documents");

**WHEREAS**, pursuant to the terms of Loan Documents, Grantors granted a security interest to the Bank in certain trademarks and/or trademark applications (the "Trademarks");

**WHEREAS**, the Rider was recorded with the United States Patent and Trademark Office at Reel 5365, Frame 0208 on September 18, 2014; and

**WHEREAS**, in consideration of the full and final satisfaction by Grantors of the Obligations in the Loan Documents creating the security interests, Bank desires to terminate and release its security interest in the Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for valuable consideration, receipt of which is hereby acknowledged, Guarantors and Bank agree as follows.

1. Bank hereby irrevocably and unconditionally terminates the Rider and terminates, cancels, releases and discharges any and all security interests granted to Bank under the Rider, including without limitation any and all rights, title and interest in and to the Trademarks, and hereby authorizes Grantors or Grantor's authorized representative to record this Release with the United States Patent and Trademark Office.

2. This Release and all acts and transactions pursuant hereto and the rights and obligations of the parties hereto shall be governed, construed and interpreted in accordance with the laws of North Carolina, without giving effect to principles of conflicts of law.

3. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
