RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (this "Release") is effective as of October 31, 2017, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as Agent (in such capacity, "Secured Party").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of August 19, 2016, by FORSYTHE TECHNOLOGY, INC., an Illinois corporation ("Forsythe"), FORSYTHE DATA CENTERS, INC., an Illinois corporation ("Forsythe Data"), FORSYTHE/MCARTHUR ASSOCIATES, INC., an Illinois corporation ("Forsythe/McArthur"), SYNNEFO TECHNOLOGY SOLUTIONS, INC., an Illinois corporation ("Synnefo" and together with Forsythe, Forsythe Data and Forsythe/McArthur, collectively, "Grantors" and each a "Grantor"), in favor of Secured Party (the "Security Agreement"), Grantors granted to Secured Party a continuing security interest in and continuing lien upon all of the Intellectual Property Collateral (as defined in the Security Agreement) of the Grantors, including without limitation, the registered trademarks and filed trademark applications listed on Exhibit A hereto; and

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on August 24, 2016 at Reel/Frame 5863/0014;

NOW, THEREFORE, Secured Party hereby (i) releases its security interest and lien upon, and terminates all other rights, title and interest in and to, the Intellectual Property Collateral, without any recourse, representation or warranty, (ii) terminates the Security Agreement, (iii) re-assigns to Grantors, any right, title or interest the Secured Party may have in, to or under the Intellectual Property Collateral, together with the goodwill of the business symbolized thereby, and hereby authorizes Grantors or Grantors' authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination, and (iv) agrees to execute and deliver to Grantors, at the Grantors' sole cost and expense, any other agreements, documents or instruments, and take any further action which is reasonably requested by any Grantor in order to effect the intent and purpose of this Release.


