**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 13, 2017 ("Release"), is made by Bank of America, N.A. ("Bank") in favor of J.M. Waller Associates, Inc., a Virginia corporation ("Pledgor").

WHEREAS, pursuant to that certain Security Agreement dated as of September 30, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Pledgor, Bank, and others party thereto, Pledgor granted to the Bank a continuing security interest in, and a right to set off against, any and all right, title and interest of Pledgor in and to trademarks, service marks, and trade names, including all goodwill connected with or symbolized by any of the foregoing including, but not limited to, the foregoing listed on Schedule A attached hereto (collectively, "Trademark Collateral"); and

WHEREAS, pursuant to the Security Agreement, Pledgor executed and delivered to Bank the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("USPTO") on October 1, 2015 at Reel 5634 Frame 0696 ("Notice").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank and Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in, and the right to set off against, Pledgor's right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the Commonwealth of Virginia.

IN WITNESS WHEREOF, the Bank has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
