## ABL TRADEMARK SECURITY AGREEMENT

### (Trademarks and Trademark Licenses)

ABL TRADEMARK SECURITY AGREEMENT, dated as of October 17, 2017, among Natvar Holdings, LLC, a Delaware limited liability company (“**Natvar**”), Plastic Specialties and Technologies, Inc., a Delaware corporation (“**PST**”), Tekni-Plex, Inc., a Delaware corporation (“**Tekni-Plex**”), PureTec Corporation, a Delaware corporation (“**PureTec**”), TP/ELM Acquisition Subsidiary, Inc., a Delaware corporation (“**TP/ELM**”), Tri-Seal Holdings, Inc., a Delaware corporation (together with Natvar, PST, Tekni-Plex, PureTec and TP/ELM, collectively, the “**Grantors**”, each a “**Grantor**”), and BMO Harris Bank N.A., as Collateral Agent.

WHEREAS, each Grantor owns, or in the case of Trademark Licenses is a party to, the Trademark Collateral (as defined below);

WHEREAS, Trident Intermediate, Inc., a Delaware corporation (“**Holdings**”), Trident Merger Sub, Inc., a Delaware corporation (“**Merger Sub**,” and as further defined in Section 1.01 of the Credit Agreement, the “**Borrower**”), certain Subsidiaries party thereto from time to time, the Lenders party thereto BMO Harris Bank N.A., as Collateral Agent and Administrative Agent, are parties to a Credit Agreement, dated as of October 17, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”);

WHEREAS, pursuant to (i) a ABL Security Agreement, dated as of October 17, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**ABL Security Agreement**”), among the Borrower, the Guarantors party thereto and BMO Harris Bank N.A., as Collateral Agent for the Secured Parties referred to therein (in such capacity, together with its successors in such capacity, the “**Grantee**”), and (ii) certain other Security Documents (including this ABL Trademark Security Agreement), each Grantor secures the Secured Obligations by granting to the Grantee for the benefit of such Secured Parties a continuing security interest in the Collateral of each Grantor, including all right, title and interest of each Grantor in, to and under the Trademark Collateral (as defined below); and

WHEREAS, terms defined in the ABL Security Agreement (or whose definitions are incorporated by reference in Section 1 of the ABL Security Agreement) and not otherwise defined herein have, as used herein, the respective meanings provided for therein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to and upon the terms and conditions contained in the ABL Security Agreement, each Grantor hereby grants to the Grantee, to secure the Secured Obligations, a continuing security interest in all of each Grantor’s right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the “**Trademark Collateral**”), whether now owned or existing or hereafter acquired or arising:

(i) each United States Trademark constituting Recordable Intellectual Property owned by each Grantor, including, without limitation, each Trademark registration and application referred to in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark;

(ii) each Trademark License constituting Recordable Intellectual Property to which each Grantor is a party, including, without limitation, each Trademark License identified in Schedule 1 hereto,

and all of the goodwill of the business connected with the use of, or symbolized by, each such Trademark licensed pursuant thereto; and

(iii) all Proceeds of and revenues from the foregoing;

provided that, notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include any Excluded Assets.



The foregoing security interest is granted in conjunction with the security interests granted by each Grantor to the Grantee pursuant to the ABL Security Agreement. Each Grantor acknowledges and affirms that the rights and remedies of the Grantee with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the ABL Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the provisions of this ABL Trademark Security Agreement and the provisions of the ABL Security Agreement, the provisions of the ABL Security Agreement shall govern.


