RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS

This RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS (this “Release”), dated as of November 28, 2017 (the “Effective Date”), is made by PNC Bank, National Association, in its capacity as Collateral Agent (the “Agent”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain Amended and Restated Security Agreement, dated as of June 18, 2014, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered an Amended and Restated Patent, Trademark and Copyright Security Agreement, dated as of June 18, 2014 (the “Patent, Trademark and Copyright Security Agreement”), for recordal with the United States Patent and Trademark Office and the United States Copyright Office;

WHEREAS, the Patent, Trademark and Copyright Security Agreement was recorded with the United States Patent and Trademark Office on June 25, 2014 at Reel/Frame 033175/0604 and at Reel/Frame 5309/0144, and at the United States Copyright Office on June 27, 2014 at Volume/Document 9912/316;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Patent, Trademark and Copyright Security Agreement, as applicable.
2. Partial Release. The Agent, without representation or warranty of any kind, hereby irrevocably releases, discharges, terminates and cancels its lien on and its security interest in and to all of the patents and patent applications set forth on Schedule 1 attached hereto, the trademark registrations and applications set forth on Schedule 2 attached hereto and the copyright registrations and applications set forth on Schedule 3 attached hereto (collectively, the “Released IP Collateral”), in each case arising under the Security Agreement and the Patent, Trademark and Copyright Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Released IP Collateral under the Patent, Trademark and Copyright Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
4. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.




