Pursuant to Section 10.10(b)(iv) of the Credit Agreement, Collateral Agent hereby releases to the Grantors and terminates, discharges and releases all right, title and interest that Collateral Agent has in, to and under the Intellectual Property and all proceeds of the foregoing; all general intangibles associated with the foregoing, including without limitation, all goodwill associated in any way with such Intellectual Property; the right to sue for past, present and future infringements; and all rights corresponding thereto associated with such Intellectual Property and any right, title and interest of the Collateral Agent in, to and under the Intellectual Property shall hereby be terminated, discharged and released and be of no further force or effect.


