RELEASE AND REASSIGNMENT OF
INTELLECTUAL PROPERTY

November 14, 2017

Reference is hereby made to that certain Intellectual Property Security Agreement (the "Agreement"), dated as of November 5, 2015, executed by ImportLA, LLC, a California limited liability company and ImportLA, Inc., a Delaware corporation, now known as Nexus Brands Group, Inc., a Delaware corporation (each a "Grantor" and collectively, "Grantors"), in favor of East West Bank, a California banking corporation ("Secured Party"), which was recorded in the Trademark Division of the United States Patent and Trademark Office ("USPTO") on November 5, 2015, at Reel 5662 Frame 0468, and with the Patent Division of the USPTO on November 5, 2015, at Reel 036972 Frame 0473, as supplemented by that certain Supplement to Intellectual Property Security Agreement (the "Supplement"), dated May 31, 2016, which was recorded in the Trademark Division of the USPTO on May 31, 2016, at Reel 5802 Frame 0890, and with the Patent Division of the USPTO on May 31, 2016, at Reel 038749 Frame 0887, and pursuant to which the Grantors assigned and granted to Secured Party a security interest in and to all of each Grantor's right, title and interest in and to certain trademarks, including those trademarks specifically listed on Schedule I attached hereto (the "Marks") and the goodwill associated therewith, and those certain patents specifically listed on Schedule II attached hereto (the "Patents"); and

WHEREAS, Secured Party wishes to terminate the Agreement and the Supplement and release, retransfer and reassign to each Grantor without representation or warranty, all of Secured Party's right, title and interest in and to the Marks and the goodwill associated therewith and the Patents;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby terminates the Agreement and the Supplement and releases, retransfers and reassigns to each Grantor without representation or warranty, any and all liens, security interests, right, title and interest of Secured Party in and to the Marks and the goodwill associated therewith and the Patents.
