## TRADEMARK ASSIGNMENT

The Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office, and the officials of corresponding entities or agencies in any applicable jurisdiction, to record and register this Trademark Assignment upon request.

This Trademark Assignment may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.

This Trademark Assignment is given pursuant to the terms of the Intellectual Property Agreement. The terms and conditions of the Purchase Agreement are incorporated herein by reference. All capitalized terms used herein not otherwise defined shall have the same meanings as set forth in the Intellectual Property Agreement. In the event of a conflict or inconsistency between the provisions of this Trademark Assignment and the provisions of the Intellectual Property Agreement, the provisions of the Intellectual Property Agreement will prevail.

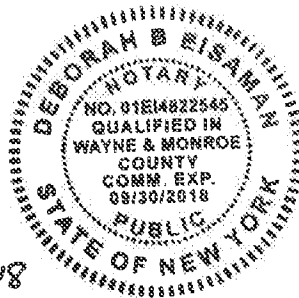

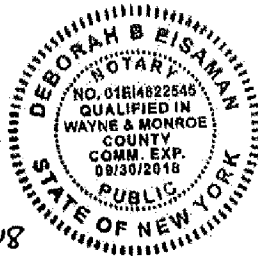
