**DISCHARGE OF SECURITY INTEREST**  
**(Trademarks)**

**WHEREAS**, GO WIRELESS, INC., a Nevada corporation (the “Grantor”), granted a security interest to U.S. BANK NATIONAL ASSOCIATION, as Administrative Agent (the “Grantee”), in the United States trademarks listed in Exhibit A-1 and Exhibit A-2 attached hereto and in the other collateral (collectively, the “Collateral”) pursuant to that certain Guaranty and Security Agreement dated as of April 14, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

**WHEREAS**, a Trademark Security Agreement (the “Existing Trademark Agreement”) given by the Grantor in favor of the Grantee with respect to the marks listed in Exhibit A-1 was entered into on April 14, 2016, and was recorded in the records of the United States Patent and Trademark Office (the “USPTO”) on April 15, 2016, and such recordation is located on Reel 5772 at Frame 0301 of the USPTO, as supplemented by that certain Supplemental Trademark Security Agreement (the “Supplemental Trademark Agreement”, together with the Existing Trademark Agreement, collectively, the “Trademark Agreement”) given by the Grantor in favor of the Grantee with respect to the marks listed in Exhibit A-2 was entered into on October 12, 2016, and was recorded in the records of the USPTO on October 12, 2016, and such recordation is located on Reel 5897 at Frame 0926 of the USPTO; and

**WHEREAS**, the Grantee desires to release the marks listed in Exhibit A-1 and Exhibit A-2 from the Trademark Agreement.


