RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 21st day of December, 2017, by PNC BANK, NATIONAL ASSOCIATION, as Lender ("Lender").

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
