RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "**Release**"), dated as of December 28, 2017, is made by BANK OF AMERICA, N.A. ("**Lender**"), in favor of MAINTECH INCORPORATED, Delaware corporation ("**Grantor**").

WITNESSETH

WHEREAS, pursuant to the Amended and Restated Trademark Security Agreement, dated as of March 6, 2017 (as amended, restated, supplemented and otherwise modified from time to time, the "**Agreement**"; capitalized terms used herein shall have the meanings ascribed thereto in the Agreement unless defined herein), recorded with the U.S. Patent and Trademark Office on March 7, 2017 at Reel/Frame 6003/0443, in which Grantor pledged and granted to Lender a security interest in and to all of the right, title and interest of Grantor in, to and under the Trademark Collateral, wherever located, and whether then existing or thereafter arising or acquired from time to time;

WHEREAS, Grantor requested that Lender release, discharge, terminate and cancel its security interest in and to the trademark registrations and applications listed on Schedule I attached hereto (the "**Trademarks**") and all other Trademark Collateral, including the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Lender, without recourse, representation or warranty of any kind or nature, and at Grantor's sole cost and expense, hereby releases, discharges, terminates and cancels its security interest in and to the Trademarks and the other Trademark Collateral.

Lender authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York.
