**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of January 3, 2018, is made by **CREDIT SUISSE AG**, in its capacity as Collateral Agent for the ratable benefit of the Secured Parties (the “**Agent**”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain First Lien Credit Agreement dated as of January 15, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among EWT Holdings III Corp. (f/k/a WTG Holdings III Corp.), a Delaware corporation (the “**Borrower**”), EWT Holdings II Corp. (f/k/a WTG Holdings II Corp.), a Delaware corporation, each Lender from time to time party thereto, Credit Suisse AG as Administrative Agent and as Collateral Agent, and the L/C Issuers referred to therein, and together with all general security agreements and intellectual property security agreements entered into in connection therewith or in connection with prior versions thereof, the Lenders and the L/C Issuers have severally agreed to make extensions of credit to the Borrower;

WHEREAS, in connection with the Credit Agreement, and pursuant to that certain First Lien Intellectual Property Security Agreement Supplement No. 2 (the “**Intellectual Property Supplement**”), the Borrower granted security interests in the certain intellectual property owned by Borrower, including those listed on Annex I attached hereto (the “**Intellectual Property Collateral**”); and

WHEREAS, the Intellectual Property Supplement was recorded in the U.S. Patent and Trademark Office and the U.S. Copyright Office on August 10, 2017 and at reel/frame No. 043262/0559.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Intellectual Property Supplement or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral to Borrower.

The Agent agrees, at Borrower’s expense, to cooperate with Borrower and to provide Borrower with the information and additional authorization reasonably required or desirable to effect the release of the Agent’s security interest in the released collateral described herein.


This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
